After careful reviews, La Jolla Pharmaceutical found that general-purpose file-sharing tools did not provide acceptable levels of security and privacy protection.

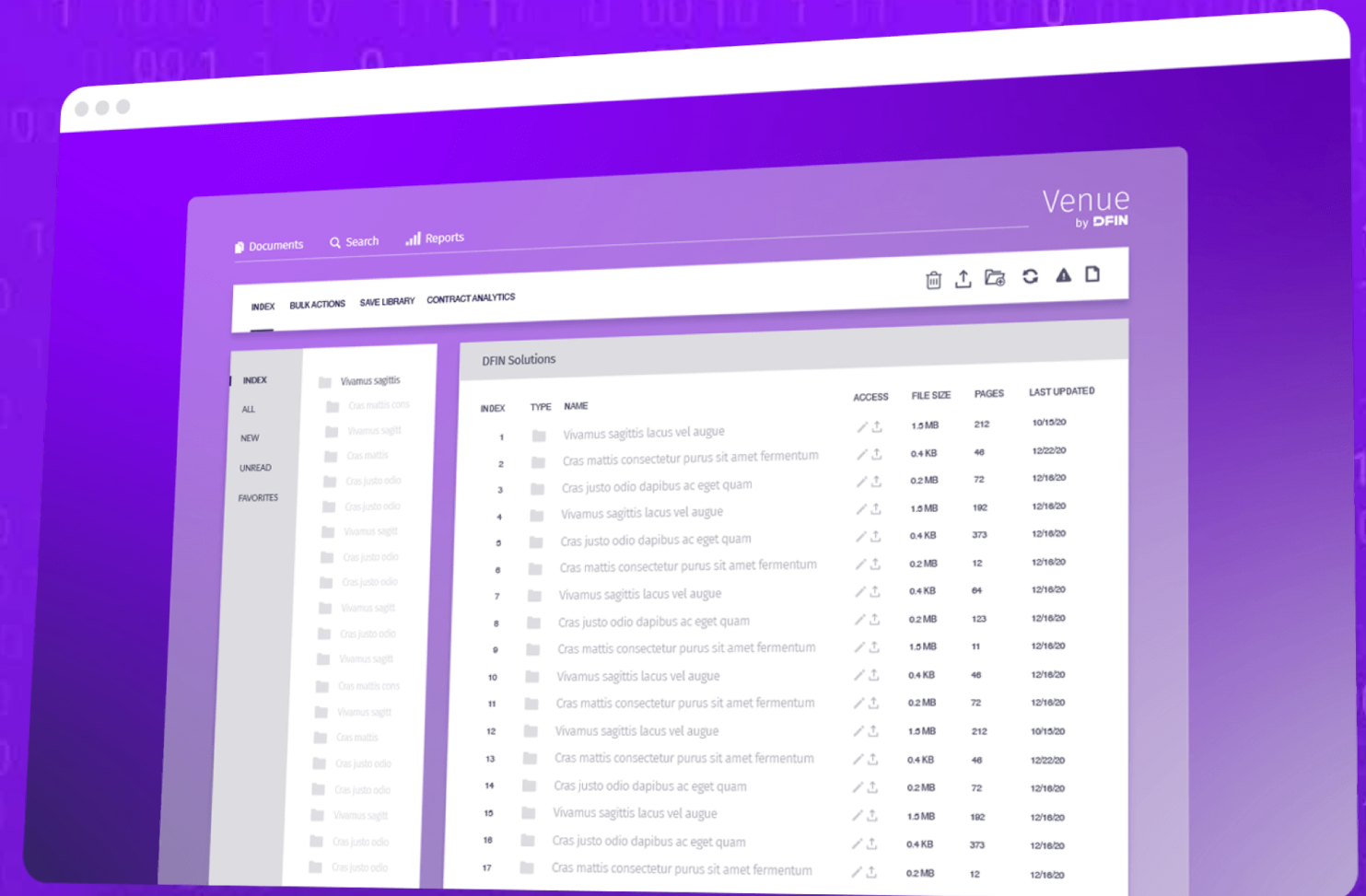

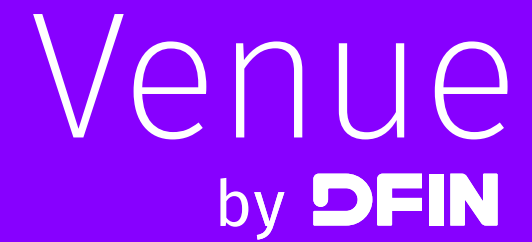

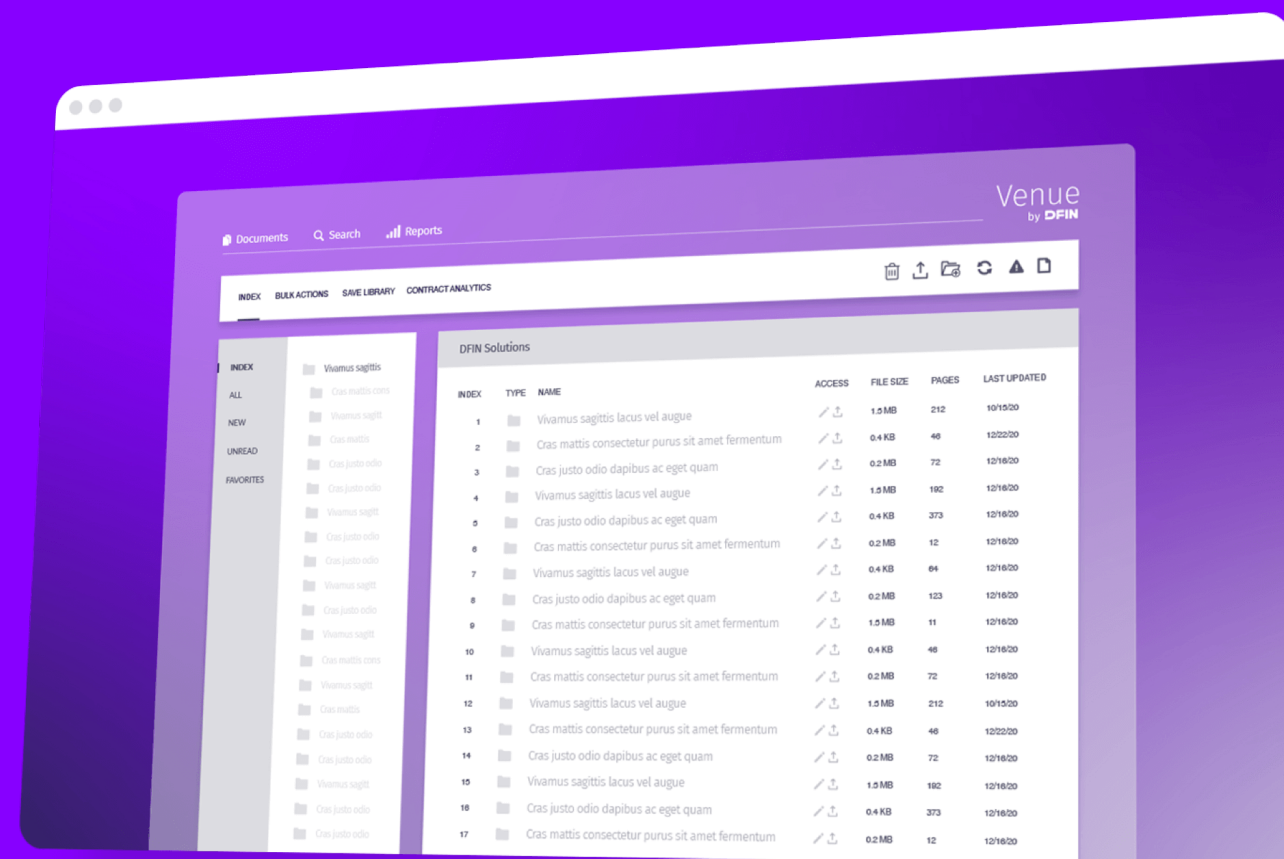
