The Liquidity Risk Management rule will also impact Form N-PORT as of November 17, 2025, and change the filing requirements to 30 days after each month-end — unless net assets of the registrant are less than \$1 billion, then the new filing deadlines take effect on May 18, 2026. ArcRegulatory will also support these requirements.
